### **Information on data protection for members (as of October 2019)**

In accordance with Articles 13 and 14 of the EU GDPR, the controller is obliged to provide the data subject whose data it processes with the information specified in the articles. In accordance with the applicable regulations, an information sheet on the obligation to provide information is required in this case.

#### **1. Names and contact details of the controller and, where applicable, its representatives**

#### **2. Purposes and legal bases of the processing**

As part of the membership administration, surname and first name, address, date of entry and, if provided, telephone number and e-mail address are processed. As part of the fee management, the bank details as well as the annual or donation fee are processed. In order to protect the legitimate interests of the association (e.g. invitations to meetings), e-mails may be sent to the e-mail address of the members.

#### **3. Recipients of personal data and transfer to third countries**

The data of the bank details of the members will be forwarded to Sparkasse Lemgo for the purpose of direct debit. A transfer to a third country is not possible.

#### **4. Storage period**

The personal data will be stored for the duration of the membership. After termination of membership, the data necessary for the administration of donations and contributions will be retained for the applicable statutory retention period (maximum 10 years after the end of the calendar year in which the membership ends or the donation was made) and then deleted. Upon termination of membership, all other data will be deleted.

#### **5. Rights of data subjects**

In accordance with the conditions set out in the articles, the data subject has the following rights:

According to Article 15 of the GDPR, there is a right to information.

According to Article 16 of the GDPR, there is a right to rectification.

According to Article 17 of the GDPR, there is a right to erasure.

According to Article 18 GDPR, there is a right to restriction of processing.

According to Article 20 of the GDPR, there is a right to data portability.

According to Article 21 of the GDPR, there is a right to object to processing.

According to Article 77 GDPR, there is a right to lodge a complaint with a corresponding supervisory authority.

In accordance with the regulations, you have the right to withdraw any consent you have given at any time.

This does not affect the lawfulness of the processing carried out on the basis of consent before its revocation.

#### **6. Source from which the personal data originates**

Personal data is generally collected as part of the acquisition of membership. Subject to the member's consent, it is possible to provide further data.
